**RE: REQUEST FOR INFORMATION ON STRANDED GHANAIS**

The High Commission is in discussion with Ethiopian Airlines and Emirates Airlines for the possible evacuation of Ghanaian nationals and holders of Ghana resident permits in India.

2. Below is Ethiopian Airline's provisional cost per passenger on chartered flights from Delhi to Accra:

- d. PRESENT LOCATION IN INDIA

7. The final cost of the air tickets will be based on the number of people who would have registered with the Mission by the deadline. Payment would be made by individual passengers to the airline through various payment channels to be announced in due course, after the necessary permits have been granted by the Government of India.
