Reference the High Commission's Public Notice dated 2nd September, 2020,

2. In view of the continued closure of Indian airports to scheduled international commercial flights, the High commission has tasked M/S Satguru Travel and tour Service ltd Accra/ Delhi to arrange the following chartered flight to evacuate Ghanaian nationals stranded in India and nationals of other countries with Ghana residence permits and valid Entry Visas on the **20th September, 2020:**

COVID PROTOCOLS

All prospective passengers are to visit www.ghs-hdf.org/hdf for Health Declaration forms and are to note that, per the new regulations at KIA, in addition to the existing COVID-19 protocols, they are required to present on arrival, a **Negative COVID-19 PCR test result** from an accredited laboratory **not more than 72 hours** before scheduled flight.

6. Passengers will also be subjected to a mandatory COVID-19 test at the airport terminal at the cost of **One Hundred and Fifty Dollars (\$150)**. Payment should be made online and the receipt presented to the airline before boarding the flight. The website address for the payment is:
